- Potential hires must be able to **remain on their feet during the entire shift and be able to lift 40 pounds.**

BEER GARDEN SERVER/POURER (3PM -10PM) Must be 21+

Take customer orders, receive tokens and serve beer, wine, soda or water under supervision of Beer Garden Supervisor. Stand at tap and continually pour beer from keg into cups, uncork wine bottles and pour into cups. Abide by all posted ABC and Downtown Sacramento Partnership rules.

GATE CHECK (3PM-10PM)

Work with on-site security and Sacramento Police Department to check bags at entrance gates to ensure no alcohol or weapons are brought into the park.

CASHIER (3PM-10PM)

Handle drink tickets purchases and revenue under supervision of the Cashier Manager and Event Coordinator.

SET UP (10AM-3PM)

Transport supplies and equipment from various storage units around the Park. Set up fencing, tables, canopies, serving areas and signage prior to opening of concerts.

TEAR DOWN (8 PM-10:30PM)

All Staff: Take down tables, canopies, serving areas and signage after concert. Return all supplies to appropriate storage units.

Tear Down Crew: Fence removal and large equipment storage \$20.00 taxable cash incentive distributed on site at completion of duties for specified Tear Down Crew.
